3.01 Special Bond Referendum Vote

On June 19, 2014, the Dobbs Ferry Board of Education voted unanimously to authorize a facility and field improvement bond referendum.

Voting will take place on Tuesday, October 21, 2014 during the hours of **7:00 AM and 9:00 PM** in the HS Gymnasium for all qualified voters.

4.01 Superintendent's Report for October 2, 2014

Dr. Brady and the Board shared feedback they received at the Ferry Festa regarding the Capital Projects Bond:

- Overall, people responded positively
- Our table was busy with people all day
- Tennis Courts will they be available to the community?
 - Yes, but not during school hours
- Why didn't the District add a track to the plans?
 - o It was cost prohibitive approximately an additional 5 million dollars and the area has limitations
- Why is the District seeking voter approval for a bond while Greenburgh is undergoing a reassessment?
 - o Retirement of current debt, interest rates and availability of state aid
- The more information being communicated the more the community is understanding the District's reasons
- Why didn't the District add air conditioning for the auditorium?
- Why isn't all the required abatement in all three schools being considered?
- Will the Springhurst turf field accommodate all sports?
 - o Lacrosse, soccer, recreation leagues, and it will be a regulation size football field
- People are happy with the plans for air conditioning Springhurst
