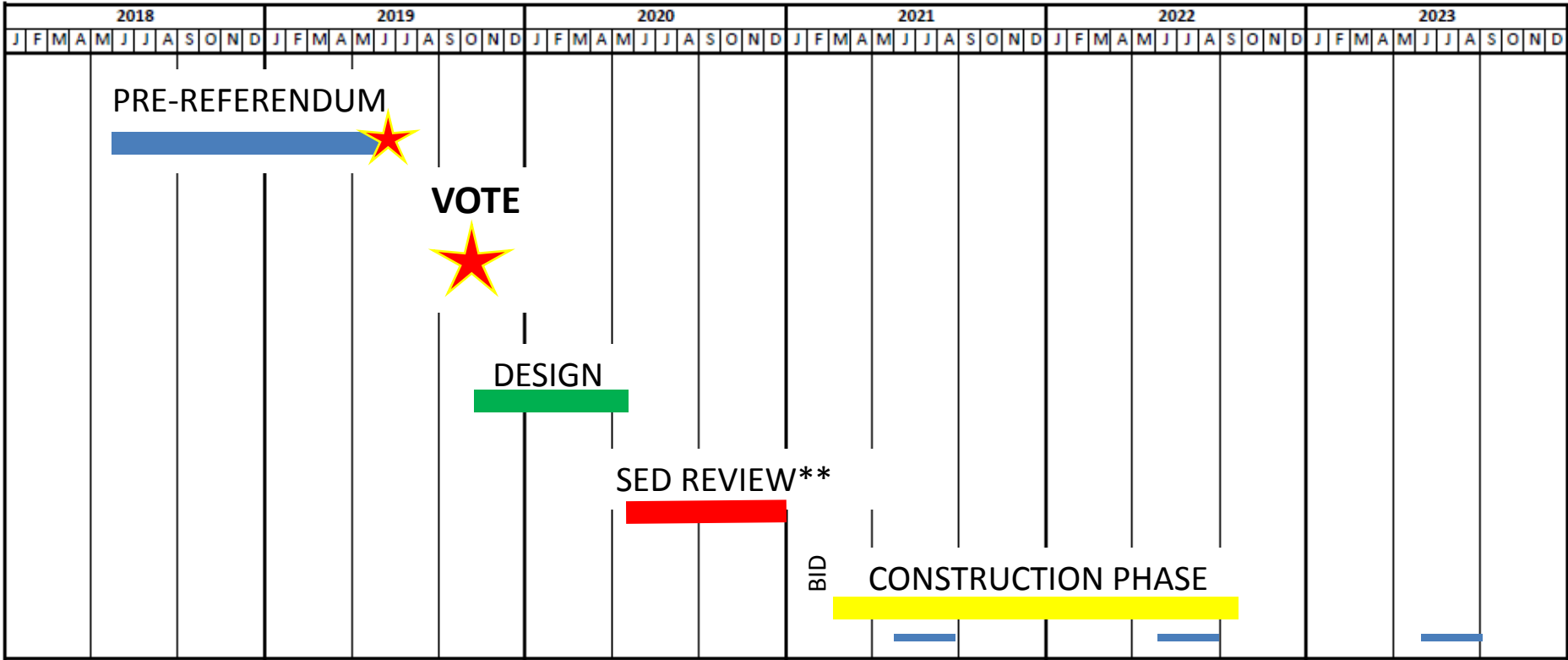

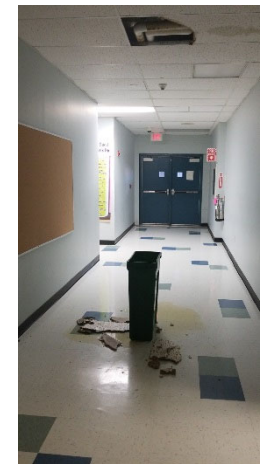

- Sitework Improvements - Springhurst Elementary
 - Sidewalk along entry drive
 - Varsity Softball field improvements
- Possible additional improvements if funds allow

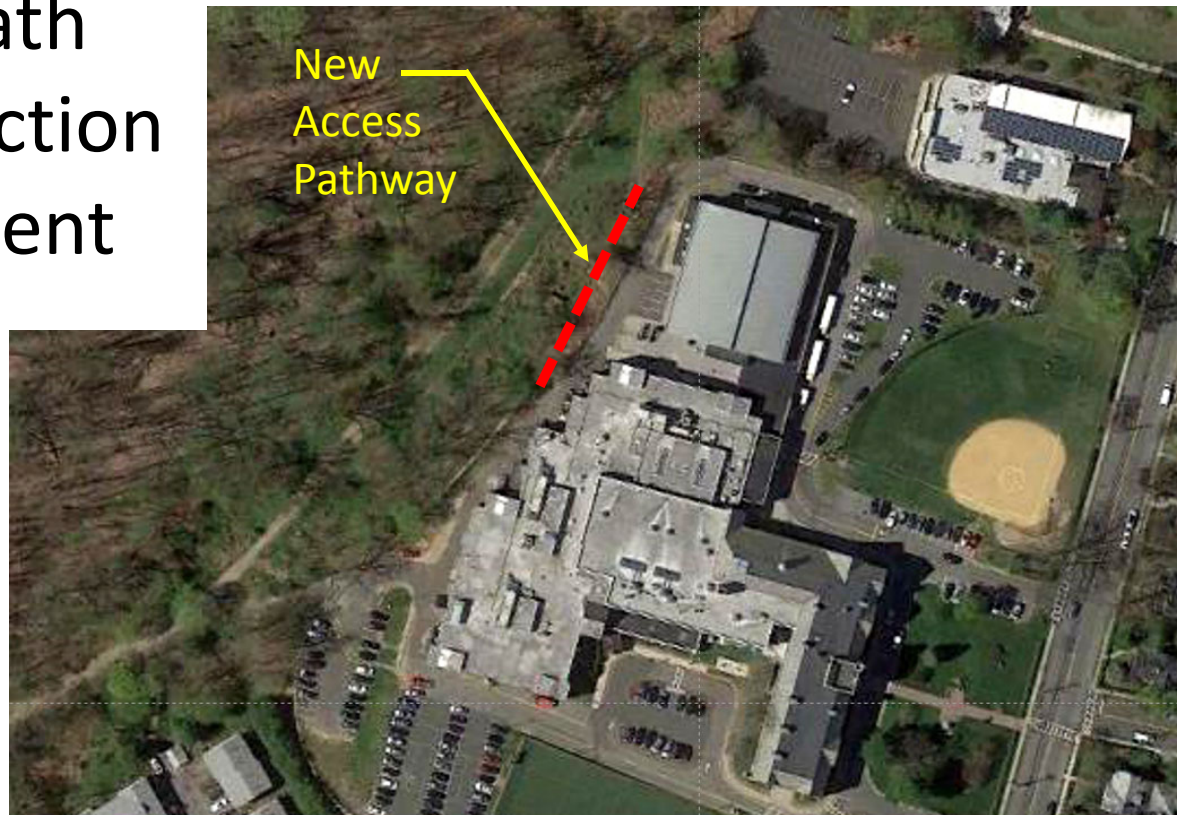

At the Middle School/High School –

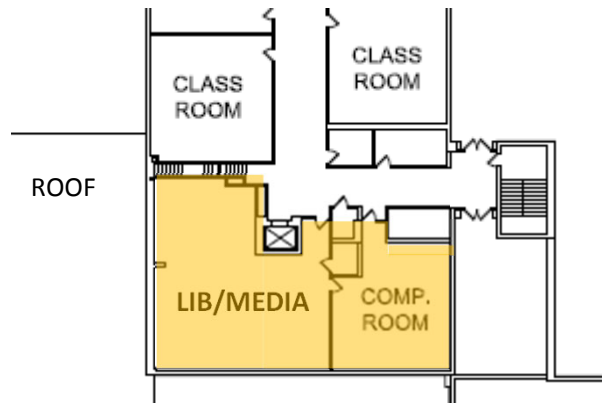
- Air conditioning will be installed in the 1st and 2nd floor High School classrooms

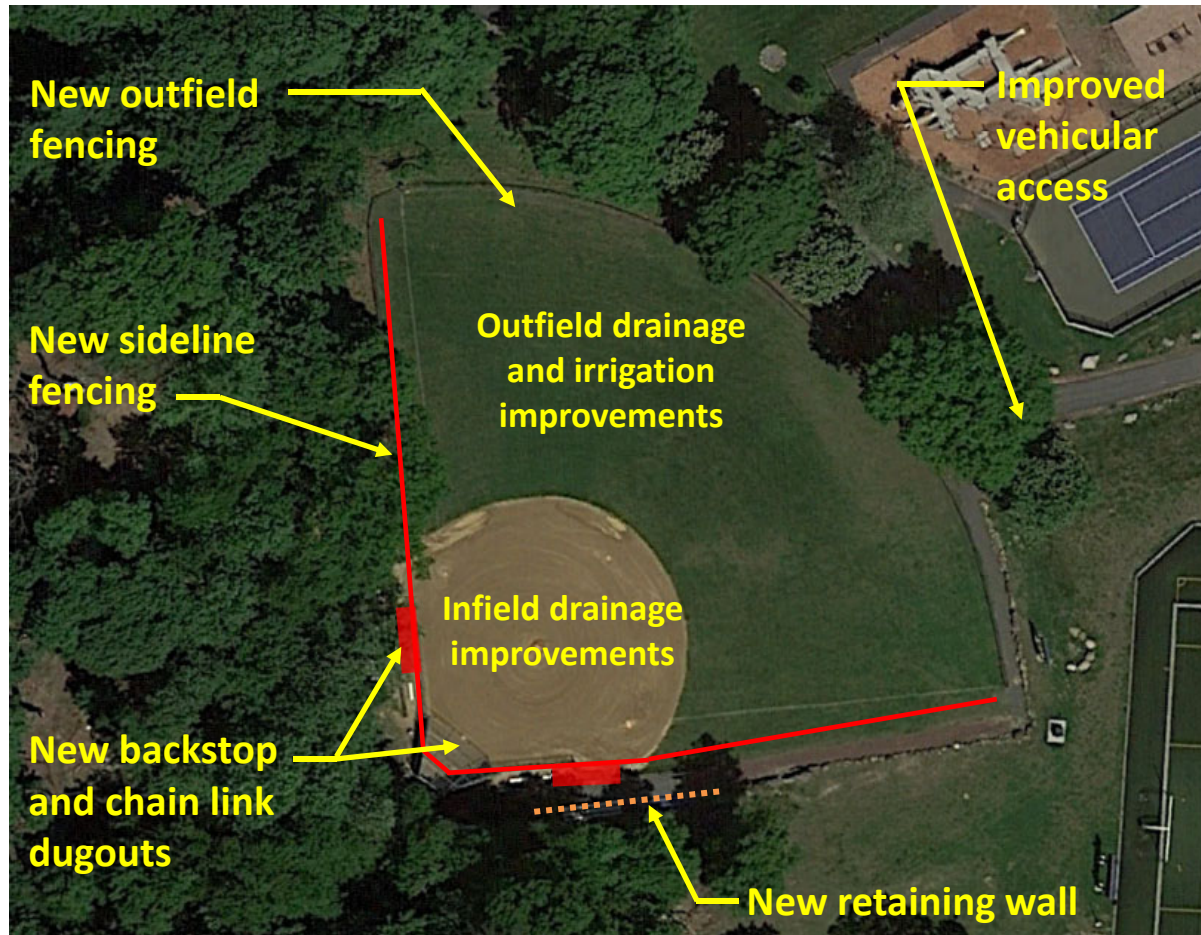

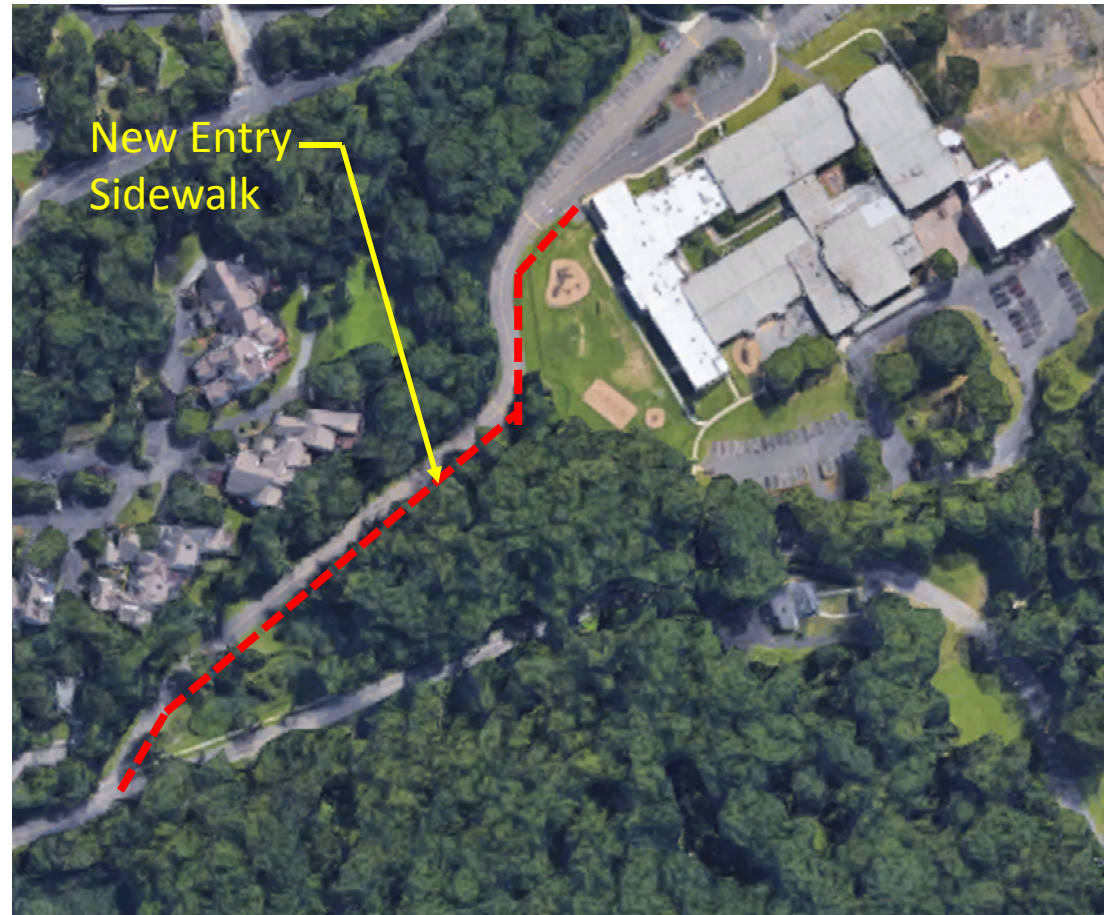

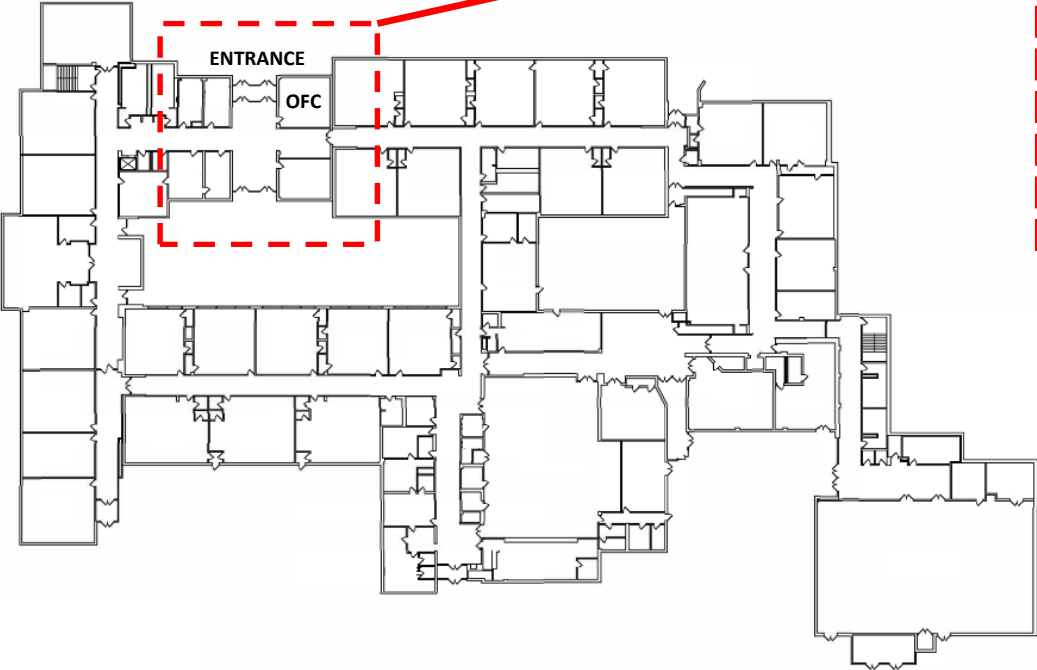

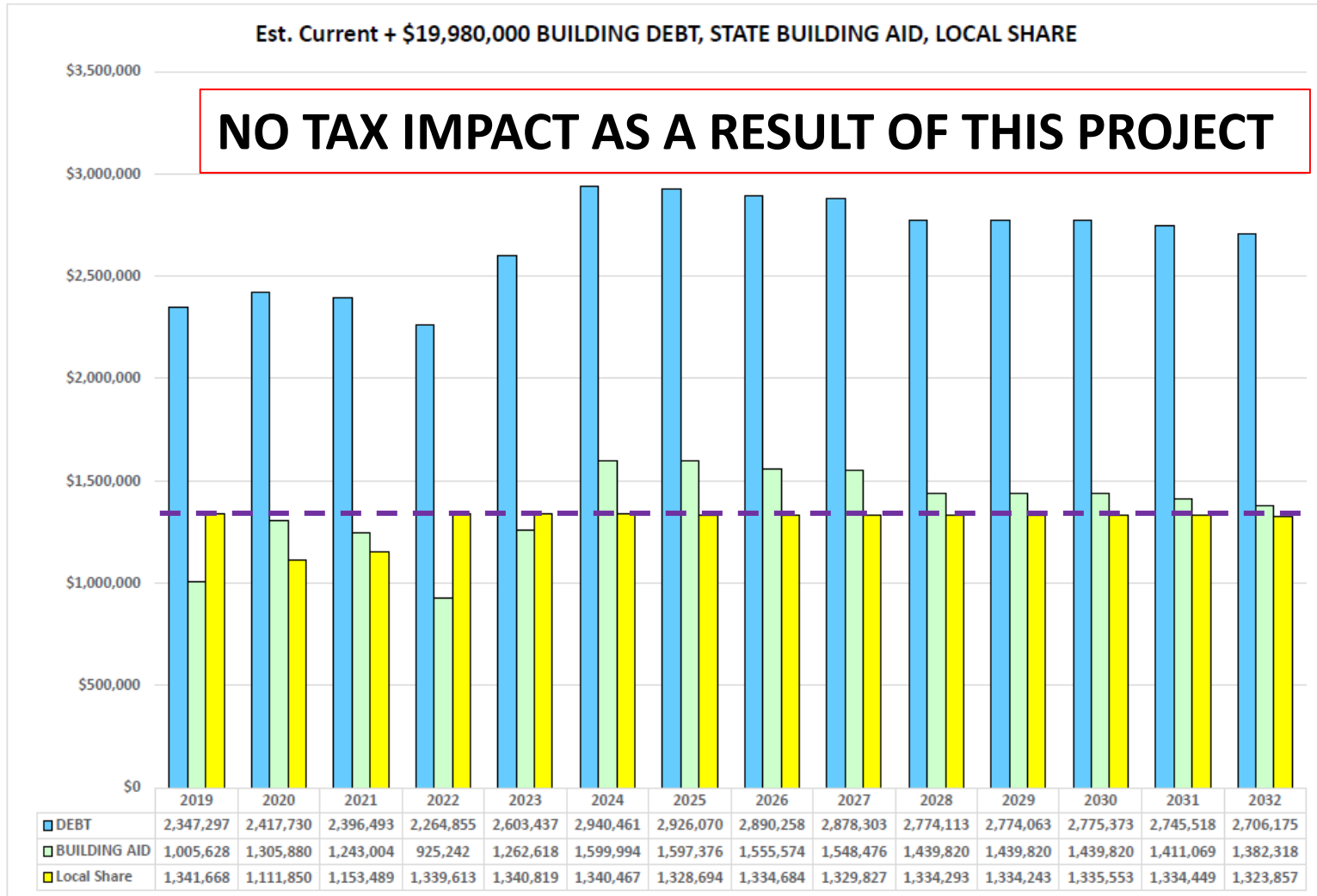

Bond Proposition

Vote YES or NO

(a) That the Board of Education of the Dobbs Ferry Union Free School District, New York, (the “District”), is hereby authorized to construct improvements to District buildings and/or sites (the “Project”), and to expend \$19,977,378 therefor; (b) that the amount of \$1,700,000 from the District’s “District-wide Capital Improvements Reserve Fund”, approved by the voters of the District on May 16, 2017, is hereby authorized to be expended to pay a portion of the cost of the Project, and such expenditure is hereby approved; and (c) that a tax in the amount of not to exceed \$18,277,378 is hereby voted to pay the balance of cost of the Project, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; and that in anticipation of said tax, the Board of Education is authorized to issue bonds of the District in the principal amount of not to exceed \$18,277,378, and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.
