# **Program Goals**

- Ensures program alignment with Strategic Plan
- Supports all instructional programs K-12
- Continues to support smaller class sizes
- Provides additional social and emotional support for students K-12
- Continues high level of professional development
- Enhances safety and security
- Continues to provide for necessary facility upgrades and maintenance



### **Key Financial Assumptions**

- Proposes no program cuts
- Ensures a budget below the tax levy cap
- Reflects the rising costs of employee health insurance
- Estimates an increase in State Aid
- Funds negotiated contractual costs



# **Tax Levy Cap**

- Established in 2011 (for 12-13 and after)
- Limits the growth of the tax levy by the lesser of 2% or CPI (consumer price index), before factoring in any allowable exclusions
- CPI is 2.44%, so the growth rate for the tax levy cap for 2019-20 is limited to 2%
- The 2019-20 *tax levy cap* for DFUFSD is 4.04%, when factoring in exclusions
- The *proposed* 2019-20 tax levy increase is 2.8% (below the tax levy cap)

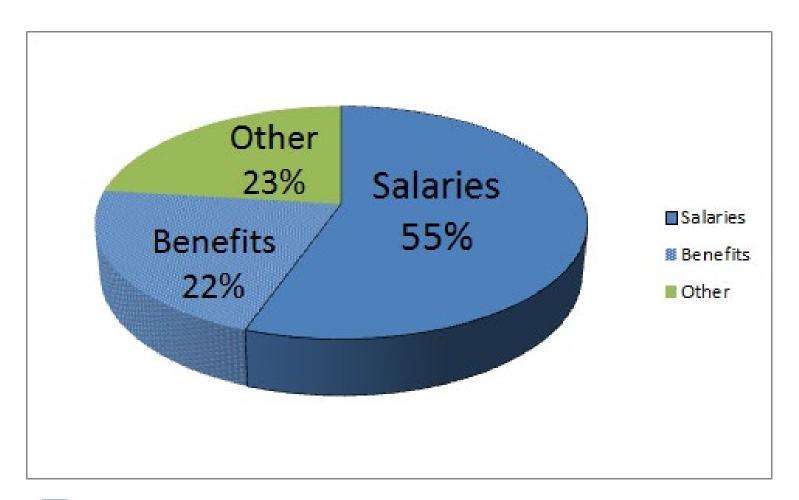

Equals: Projected Tax Levy	\$38,320,304	
Divided by: Estimated Taxable Assessments	\$1,765,010,733	
Multiplied by 1,000		
Equals: Projected Tax Rate per \$1,000 Assessment \$21.71		
(Tax Levy / Taxable Assessments x 1,000 = Tax Rate per 1,000)
