Children need healthy meals to learn. **Dobbs Ferry School District** offers healthy meals every school day. Breakfast costs \$1.25; lunch costs \$2.75. Your children may qualify for free meals or for reduced price meals. **Beginning July 1, 2019**, **students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge**.

- DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Complete the application to apply for free or reduced price meals. How to Apply: To get free or reduced price meals for your children carefully complete one application following the instructions for your household and return it to the designated office listed on the application.
