5. Work Session Topic

5.01 School Awards

The group discussed the merits of legacy practices as well as new thinking about the value and merits of whether awards and awards ceremonies act as incentive and motivation for students to learn and addressed the following questions:

Do you ever wonder about the "how and why" of school academic, athletic and other awards? Do you sometimes wonder whether the "awarding of awards" is helpful or harmful? Do awards still have a place in a 21st Century learning environment in an IB school?

Discussion included:

- The criteria for each school's awards.
- Should awards be GPA driven?
- Is competition counter-productive?
- How do awards affect both students with awards and those without?
- The types of awards and the criteria need to be re-visited.
- How do award based goals limit life-long learners?
- Are awards honoring what we value?
- Many colleges still look for applicants' awards.
- Awards shouldn't be given because it was always done.
- Our process can't be changed overnight.
- It will take incremental change.
- We can begin with adjustments.
- Students will be solicited for their input on the awards and the process.
