8. Work Session Topic

8.01 Social and Emotional Learning

The session included Administration, Board members, and two parents/community members. Dr. Brady explained how Social and Emotional Learning is a component of our Strategic Plan and a major topic for all Districts in today's environment.

Tonight will we concentrate on Mindfulness in the classrooms and over the course of the year we will have a variety of reports about what we are doing in the schools. Andrew Klaich will report on the audit and student survey findings and how we stack up against the core competencies as determined by Castle.

Dr. Brady introduced Laura Metrano, teacher and early adopter, who is certified in yoga and mindfulness, and practices it in her third grade classroom.

Ms. Metrano led the group in a Mindfulness session which included "Candle Gazing Meditation.

Mindfulness is:

- A non-judgmental, present-centered attention of what is happening within as well as around oneself
- It is a type of meditation
- It is proven to improve numerous mental abilities
- All is based on science
- Gave a list of Meditation/Mindfulness Books for both children and adults

Dr. Brady and the Board thanked Ms. Metrano for coming to tonight's meeting and leading the group.

Ms. Metrano expressed that she is grateful that the District is involved.
