## 3.01 SWBOCES Trustee & Budget Vote

Wooley, Catherine Draper, and Lynn Frazer-McBride for the time period of July 1, 2016 through June 30, 2019 and the 2016-2017 Estimated Administrative Budget of \$10,461,257.00 for the Southern Westchester Board of Cooperative Educational Services.

The Board noted that the change in this year's vote from a no to a yes for the budget is due to BOCES' consideration of the budget constraints that all School Districts are forced to comply with when creating their budget.
