4.01 Personal Voter Registration

Any community resident not registered with the Westchester County Board of Elections may do so during Personal Registration which will take place on **Monday, May 10, 2021**, between **3:30 PM and 7:30 PM** in the HS Gymnasium Foyer. Voter Qualifications: (1) Must be a citizen of the United States; (2) Must be 18 years

of age or older; (3) Must have been a resident of the school district for a period of 30 days or more prior to May 18, 2021.

4.02 Absentee Ballot Information

The Governor continued to extend the Education Law provisions regarding absentee ballots (2018-a and 2018-b) to include the potential for contracting the COVID-19 virus as an illness as a legitimate reason for receiving an absentee ballot. It means that if someone checks the "illness or disability" box on the absentee ballot application, fear of having COVID-19 is included within that category.

Absentee Ballot Applications may be requested in writing or by email: District Clerk Superintendent's Office Dobbs Ferry High School 505 Broadway Dobbs Ferry, New York 10522 tularzkol@dfsd.org

Upon receiving a timely application for an absentee ballot, the District Clerk will send it to the voter via US Mail or email. Completed applications must be received by the District Clerk no more than thirty (30) days and at least seven (7) days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be emailed or picked up personally by the voter or the voter's authorized agent set forth in the application at the District Clerk's Office.

Completed absentee ballots must be received in person or US Mail no later than 5:00 PM, prevailing time, on May 18, 2021.

Voter Qualifications:

- Must be a citizen of the United States.
- Must be 18 years of age or older.
- Must have been a resident of the school district for a period of 30 days or more prior to May 18, 2021.

4.03 In-Person Voting Guidelines for the Trustee and Budget on May 18th

Individuals entering the school for in-person voting

- Must be in good health:
- Have not been in close contact in the past 10 days with anyone who has tested positive for COVID-19, or who had symptoms of COVID-19
- Have not tested positive for COVID-19 in the past 10 days
- Have not experienced any symptoms of COVID-19, including a temperature of greater than 100.0°F, in the past 10 days
- Have not traveled internationally per the New York State Travel Advisory in the past 10 days
- Must enter the school via the HS Gym Entrance
- Wear a mask masks will be provided should you need one
- Maintain six feet social distance while waiting in registration lines, for privacy booths and for voting machines
- Refrain from lingering and socializing with others
- Hand sanitizing gel and wipes will be provided
- Barriers will be installed at registration tables
- Pens will be sanitized after each use and surfaces will be sanitized throughout the day
- During busy times, voters may need to wait in line outside the Gym and possibly the building

8.02 Veterans' Tax Exemption

Ms. Johnson moved, and Mr. Bufalini seconded, that the Board adopt the following:

WHEREAS, the Board of Education of the Dobbs Ferry Union Free School District wishes to adopt the provisions of Section 458-a of the Real Property Tax Law which would grant a partial exemption from taxation for school district purposes of certain real property situated in the School District and owned and used as the primary residence by eligible veterans (Alternative Veterans' Exemption); and

NOW, THEREFORE, BE IT RESOLVED, that the Board, after having conducted a public hearing on April 13, 2021 and having given the public an opportunity to be heard on the issue of the Board's proposed adoption of the Alternative Veterans' Exemption pursuant to Section 458-a of the Real Property Tax law, hereby adopts the Alternative Veterans' Exemption for assessment rolls prepared on the basis of the taxable status date occurring on or after May 1, 2021, at the following basic maximum levels:

- 1. Basic Exemption Tax exemption of 15% of the assessed value of the property, not to exceed \$12,000 or the product of \$12,000 multiplied by the latest state equalization rate for the assessing unit, whichever is less.
- Combat Zone An additional tax exemption of 10% of the assessed value of qualifying residential property
 of veterans who are documented to have served in a combat zone, not to exceed \$8,000 or the product of
 \$8,000 multiplied by the latest state equalization rate, whichever is less.

3. Disabled Veterans - In addition to the above exemptions, where the veteran received a compensation rating from the Veterans' Administration or Department of Defense based upon a service-related disability, the qualifying residential property will be exempt to the extent of the product of the assessed value multiplied by 50% of the veteran's disability rating, not to exceed \$40,000 or the product of \$40,000 multiplied by the latest state equalization rate, whichever is less; and

BE IT FURTHER RESOLVED, that the Board directs the District Clerk to provide a certified copy of this resolution to Westchester County and the assessors for the other taxing jurisdictions located within this School District.

Mr. Schwartz thanked the Veterans for their service and their patience in waiting for this exemption to be approved.

12. New Business

- WPSBA Town Hall summary board members were reporting on some increased quarantines that are happening in schools around the area.
 - We've had to quarantine kids un Dobbs Ferry
- Some districts report parents are pushing back either saying no, I refuse to quarantine my kid, or the
 opposite.
- Some folks are talking about trying to have board meetings in person and some are not.
- Some are trying to figure out ways to combine an in person meeting and also allowing members of the public to participate through a zoom or a Google meet type of thing which is complicated to do.
- A lot of the districts on the call are doing surveillance testing.
 - Generally, they seem to be doing around between 5% and 10% random testing among people whose parents have agreed on each week. Irvington, as an example, is doing that and is doing extra random sampling testing of student athletes.
 - Dr. Brady explained that the feedback from her colleagues is that they are not picking up very many positive kids via surveillance testing.
 - We decided to take more of a wait and see kind of approach. If we were beginning to see an elevated number of students testing positive for COVID.
 - It's something we could do. We are approved to get the Binax cards from the state. We completed that paperwork and we will wait and see.
 - We did have to quarantine students this week, in the middle school in the high school, but our positive number of positive student cases is very low.
 - And one of the things that we talked about Monday in our Department of Health phone call is that overall transmission rates inside of schools is almost non-existent.
 - It's coming from the outside, but it's not happening inside of school. So we'll see if we need to go down that road. We're prepared to do that. And we can and we will.
- Residents have received notifications from Tyler Technologies regarding their assessment, and there's a lot of confusion about it means?
 - Their new estimated assessed value of their property may have increased and some property values may have decreased which may cause a change in their property taxes.
 - This will be for the next taxing cycle.
