## 5. Announcements

Ms. Lucasey announced information about Private School Transportation Requests:

Residents of the district whose students will attend a non-public school in 2024-25 and require bus service must submit a request form online **by April 1, 2024** (even if placement has not yet been confirmed) to the Ardsley Transportation Department. To be eligible, students must be at least 5 years old, in grades K-12 (not preschool) and the school must be within 15 miles of their home. You must also meet the minimum district mileage requirements. To apply online, visit ardsleyschools.org and click on Departments >Transportation > Transportation To A Non-Public School. Parents should note that a <u>separate</u> request must be submitted for <u>each school</u> being considered. Requests may be withdrawn if a school is not selected, but **may not** be considered if submitted after the deadline).

The School Board has established a firm policy of not considering requests submitted after the deadline.

## 6.01 Student Support Services

Mr. Slentz gave a presentation on the District's Student Support Services: Alignment with the schools goals, specifically Goal #3 (K-12 MTSS plan) and Goal #6 (Wellness Framework); personnel involved (school counselors, school psychologists, school social workers, behavior specialist, student assistance counselor, school nurses, and coordinator of K-5 student support services) and programs at K-5, Middle School and High School, Instruction and Training.

## Policy Committee

## 8.07 Increase to 2023-2024 Budget.

**BE IT RESOLVED**, that the Board hereby directs the Superintendent of Schools to move monies from the Unassigned Fund Balance of the District's 2023-24 School Year Budget, in the amount of \$472,812 (Budget Code A5997.917), to pay for unanticipated costs, which constitute ordinary contingent expenses, incurred after voter approval of the 2023-24 School Year Budget as described in the chart below; and

**BE IT FURTHER RESOLVED** that the District's 2023-24 School Year Budget is hereby increased by the appropriation of \$472,812.00 from unassigned fund balance.

Ms. Stringer moved and Ms. Hershberg seconded, to approve the resolution.

Due to the state-required timeline for the adoption of this policy by February 3, 2024 the Board waived the second reading of this policy in accordance with the rules set forth in Policy 2410. Ms. Stringer gave an overview of the policy, which is required by all school districts.
