7.01 2023-24 Budget Presentation

Dr. Clamser and Mr. Slentz presented the recommended 2023-2024 Budget to the Board as detailed on the slide deck posted on the District Budget Information webpage.

Board members discussed the implications of the tax levy on individual taxpayers and alternative revenue solutions that could be considered to offset the proposed tax levy.

Dr. Clamser reminded the Board that the 5.02% proposed increase to the tax levy was not a 5.02% increase in an individual tax bill and that the Board was not being asked to approve the proposed tax levy tonight but rather to approve the proposed expenditure plan. The Board approves the tax levy later in the school year or early summer.

7.02 BOCES Administrative Budget

Dr. Clamser provided an overview of the proposed 2023-2024 Southern Westchester BOCES administrative budget as detailed on the posted slide deck and information sheet.

8. Superintendent Report

8.01 Student Achievements and Performances

Mr. Slentz provided an overview of co-curricular and extracurricular student successes since our last meeting, including performances of Chicago: Teen Addition, and the recognition of five of our winter sports teams by Section 1 as Scholar Athlete Teams: women's basketball, bowling and indoor track; and men's bowling and indoor track. Mr. Slentz highlighted the success of the first season of Unified Bowlingand the 100 goals scored by senior lacrosse player Jacqueline O'Connor.

9.05 Partial Tax Exemption for Qualified Persons Aged 65 or Older and for Qualified Persons with Disabilities and Limited Income

BE IT RESOLVED, that real property owned by one or more persons, each of whom is 65 years of age or over, or who qualify as persons with disabilities and limited income as defined by Section 459-c of the Real Property Tax Law, shall be exempt from taxation by the Board of Education of the Dobbs Ferry UFSD of the town of Greenburgh in Westchester County, State of New York, to the extent of 50% of the assessed valuation thereof, subject to the provisions and limitation contained in Sections 467 and 459 of the Real Property Tax Law of the State of New York; provided however, that the property is vested in either spouse, the combined income of both spouses for the income tax year immediately preceding the date of making the application for exemption is \$37,399.99 or less. This exemption would be in effect from July 1, 2023, through June 30, 2024.
