#### Role of the BOE

- It is like a Board of Directors
- It is governance, not management or operations
- They establish goals, set priorities, set policy and oversee resources for the school district
- Most important functions of the BOE
  - Hire and evaluate the superintendent
  - Set priorities and monitor progress
  - Submit a proposed budget to the voters that aligns with the priorities
- Oversees the superintendent while not micromanaging the day to day operations

#### Role of the Superintendent

- Is like the chief executive officer
- Educational leader of the district
- Manages and runs day to day operations
- Takes goals and priorities of the BOE and translates them into action
- Manages the employees of the district

The School Board governs and the Superintendent administers.

## **Andy Office Visit**

A Board member was following a school bus around because he was told the bus driver was driving unsafely.

The discussion included:

- How the Board Member in the Andy Office Visit video overstepped his role as a Board Member.
- Board Members explained how much time is involved in being on the Board.
- The newer Board Members explained what their perception of being a Board Member were and what the job actually entails.
- The superintendent and the Board need a supportive, respectful and cohesive relationship.
- The attendees were asked why they would and would not run for the Board.
  - o The main reason for not running is the time involved.
- The Board policies are dictated by state and financial mandates.
  - Under New York State law, a huge regulation is that the Board has to follow the Open Meetings law, which directs the Board on how they meet. It is very clear that they can take no action or decision as an individual, only as a group, in a duly noticed public meeting where a quorum of the Board is present.
