- We want to make sure that our goals are a reminder of all the work that sits underneath the large body of work that we do each day.
- Our Goals are in line with our Vision; Mission; Core Values; Diversity, Equity, and Inclusion Plan; Strategic Plan; and Board Policy, the Dobbs Ferry School District and Board of Education have developed the following goals to guide our work in the 2022-23 school year.

- Is it possible to stagger the progress status rather than all the goal status reports are in January, March and June?
 - People in the committees are going to need to be up to speed on their particular strands.
 - As a board member, I feel it's a lot of work and I want to be able to absorb it.
- Where is the communication strand?
 - I think we need to really think about having something specific in the strategic plan about how we communicate or that we will develop a plan to communicate our findings in progress.
- This document by no means reflects all of the work that we're doing.
- We should let our communities know about the communications tools we use, assuring the effectiveness of our communication.
- A complete review of the K-5 literacy is it because we haven't done one in a while or is that something particular that had been brought to your attention?
- are we going to get a report on the testing data?
 - The state finally released all of the data just this week. So yes you will get a report.
- We need to be very cognizant of the load on teachers right now by adding one more thing.
 It's October and people are feeling January tired already.
- The long range facilities plan and the long range finance plan are probably pretty intimately connected.
- We should hold a focus group on the safety component of these goals. Nothing else matters when safety is in jeopardy for a parent.
- Do we envision having a front page with simple goals similar to what we have done in the last four or five years?
- What about the DEI task force or Race Matters committee that is in our policy?
 - We would want to mention that somewhere in the goals since this is a high priority.
- It is important to make sure that our instructional staff in particular feels very well-supported in terms of their professional learning.
- Tonight is not your only shot at this. Send in comments to Jean or myself if you have them.
- Next steps after this evening will be to continue to take feedback on this, have conversations with
 respective administrative teams around this and then we anticipate coming back with a revised
 document November 1st for Board adoption.
- This document will probably remain as a draft as we continue to add strategies along the way and again as we build the January, March and June updates.

MINUTES

Shannon Stringer attended the annual business meeting of the New York State School Boards Association last week on behalf of the Board.

- It was a 5 ^{1/2} hour meeting. There were many passionate discussions around several of the resolutions.
- A lot of people had a lot to say, especially on the ten resolutions that were not supported by the Board.
- The ones that had the most discussion were the ones that we discussed.
 - Support for universal pre-K. There was an amendment that was added and approved that was said it would be fully funded by the state,
 - It passed 86% to 3%.
 - Providing specialized training to security guards on the regulations of education.
 It was 46% yes and 54% no.
 - The one about school board stipends.
 - Did not pass 36%, 64%.
 - The gun law resolution amendment to include storage was not passed.
 - The resolution itself did not pass 45 to 55.
 - The other interesting ones were not recommended for adoption which included things like allowing reinstatement of religious or moral objection to immunization.
 - Another was to allow every child in New York State to be covered for free under the Child Health Plus program.
 - The child health care one did not pass 43 to 57
 - Having some kind of alternative form of assessment for certain students for whom the regents were a psychological or physical burden.
 - It did not pass, but it was close 47 to 53.

Shannon stated that is was worthwhile and really interesting.
