6.01 Tax Certiorari Refunds

Ms. Johnson moved, and Ms. Baron seconded, that the Board authorize the following Tax Certiorari Refunds:

\$91,504.76* to be transferred from the District's Appropriated Reserve for Tax Certiorari to its General Fund to enable it to pay a tax certiorari refund in that amount to 110-150 Drapers Owners Corp. as previously consented to at the March 27, 2018 Board meeting.

(*Note that this amount is higher than the amount originally projected due to delays in obtaining the approval of the Town and the Court. It does not change the terms of the original settlement, which has previously been approved.)

\$39,132.86 to be transferred from the District's Appropriated Reserve for Tax Certiorari to its General Fund to enable it to pay a tax certiorari refund in that amount to Gramercy Capital Corp. as previously consented to at the March 27, 2018 Board meeting.

\$9,209.93 to be transferred from the District's Appropriated Reserve for Tax Certiorari to its General Fund to enable it to pay a tax certiorari refund in that amount to Hudson House Tenants Corp. as previously consented to at the July 2, 2018 Board meeting.

8. Work Session Topic

8.01 Civic Engagement

Dr. Brady began by explaining that this topic was one of the topics the Board expressed interest in during their retreat.

Dr. Brady introduced Dr. Giselle Martin-Kniep, Ph.D., President, Learner-Centered Initiatives, Ltd., who facilitated the session. Dr. Brady and Dr. Martin-Kniep presented this topic two weeks ago at the Learning Forward Conference in Dallas.

Discussion:

- Civic education has been mandatory since the beginning of the public school system.
- Civic engagement is not really clear there are differences and similarities in individual ideas.
- It needs a curiosity and willingness to engage; being informed of community issues; making a difference; volunteering in organizations; recognition of our own bias; not afraid to get into a difficult conversation; and a willingness to be offended.
- The participants explored the following questions and were asked in what curriculum contexts (i.e., social studies, ELA, etc.,) or settings (i.e., student government, service learning, etc.,) could students engage with each of these questions?
 - What is civic engagement?
 - What are the questions that a civically engaged student/person would ask?
 - What conclusions can we draw about the role of schools in civic engagement?

Questions to think about:

- How do you help kids to learn to discuss in a difficult conversation?
- What opportunity do we give kids to care?
- What are other schools doing?
- What are we doing already or not doing?

Dr. Martin-Kniep gave three sheets of selected resources on Civic Engagement that the group could read on their own.

Dr. Brady and the Board thanked Dr. Martin-Kniep for the work session.
